New directives such as the PSD2 regulation introduced in January open up banks' systems to other service providers, creating new business models and with them the potential for breaches and fraudulent activities.

Fraud detection before a transaction is made, along with user-friendliness to ensure efficient management of risk models achieve considerable cost savings for banks.
